#### 2.1 **Production Release: January 8, 2022**

External testing: December 28, 2022

The API changes noted below will be released to production in the late-night hours of January 6. USPS is enacting a Price Change on January 9, 2022, which will be available on January 6 when using a ship date of January 9 or beyond. <u>All domestic and international price calculator and shipping label APIs will reflect updated pricing</u> in XML responses, on shipping label images, and in the Shipping Services Files (see Appendix A for full list of price calculator and label APIs). Changes beyond basic price updates are explained below, per API.

### 2.1.3 Domestic Price Calculator API – USPS Retail Ground Updates (API=RateV4)

- 1. Summary: USPS Retail Ground will be available for zones 1-4 even if the contents do not contain hazardous materials (i.e., HAZMAT).
  - The RateV4 API will support USPS Retail Ground pricing and availability for zones 1-4 when <Service>="Retail Ground".

### 2.1.4 Domestic Price Calculator API – USPS Tracking Plus Updates (API=RateV4)

- Summary: USPS will expand the product offering that supports USPS Tracking Plus option to allow a customer to purchase extended retention of tracking data on their mail piece for varying lengths of time up to 10 years when available. USPS Tracking Plus will now be available for Bound Printed Matter, Media Mail, Library Mail, First Class Mail (Letters and Flats) and USPS Marketing Mail products.

  - New <Container> enumerations: "SM FLAT RATE BAG", "LG FLAT RATE BAG", "FLAT RATE BOX" will be added to return USPS Connect Local Flat Rate pricing and availability when included in the XML request with <Service>="Connect Local."
    - USPS Connect Local Small Flat Rate Bag will be indicated by mail class identifier "89" (i.e., CLASSID="89") in XML response when XML request includes <Container>= "SM FLAT RATE BAG."
    - USPS Connect Local Large Flat Rate Bag will be indicated by mail class identifier "90" (i.e., CLASSID="90") in XML response when XML request includes <Container>= "LG FLAT RATE BAG."
    - USPS Connect Local Flat Rate Box will be indicated by mail class identifier "91" (i.e., CLASSID="91") in XML response when XML request includes <Container>= "FLAT RATE BOX."

- Summary: Effective April 3, 2022, USPS will enforce new Nonstandard Volume and Length Fees for parcels that exceed 2 cubic feet (3546 cubic inches) or have a length greater than 22 inches. Reference https://www.prc.gov/docs/120/120310/Notice.Delayed.Imp.pdf and pe.usps.com/text/dmm300/notice123.htm for details.

- 1. Summary: Web Tools will update impacted APIs with new HAZMAT indictors to support increased Hazardous Materials (HAZMAT) visibility within the Postal network. USPSReturnsLabel API will be updated to support new HAZMAT indicators including extra services, mail classes, and related service type codes, service icons, banner text, label markings, and new Shipping Services File (SSF) inputs so that HAZMAT labels can be easily identified.
  - Impacted API: USPSReturnsLabel
  - New <ExtraService> enumerations to indicate type of HAZMAT reference above table in section 2.13.1. There are no fees associated; a price of "0.00" will return in the XML response.
  - All 23 new HAZMAT extra services (passed in the <ExtraService> request tag) will be eligible for domestic shipping destinations.

- New Service Type Codes (STCs) for HAZMAT will be used in IMpb barcode generated which is returned in API response, displayed on the label image, and passed in the Shipping Services File (SSF).
- New service icon "H" will be used for HAZMAT.
- New banner text will be displayed for HAZMAT.
- New label marking "HAZMAT Surface Transportation Only" for Ground Return Service product with HAZMAT.
- Reference Appendix B for sample HAZMAT label.
- For HAZMAT, Web Tools will update the Shipping Services File Extra Service Code (ESC) fields SSFv2.0 D1, pos 44, 46) as follows:
  - Web Tools will include "857" (generic HAZMAT) and the new detailed HAZMAT extra services "810-832" where supported reference above table in section 2.13.1
  - Web Tools will remove "455" (deprecated ESC for USPS Returns). ESC "452" (USPS Returns) will be used to indicate USPS Returns.

Impacted label APIs will be updated to support new HAZMAT indicators including extra services and new Shipping Services File (SSF) inputs so that HAZMAT labels can be easily identified.
  - Impacted APIs:

    - eVSFirstClassMailIntl (eVSFCMI)
  - New <ExtraService> enumerations to indicate type of HAZMAT reference above table in section 2.13.2. There are no fees associated; a price of "0.00" will return in the XML response.
    - Only 3 HAZMAT extra services "813", "820", and "826" (passed in the <ExtraService> request tag) will be eligible for international destinations.
  - Customs forms to an international destination will require a content type of dangerous goods when shipping HAZMAT.
    - When HAZMAT extra services "813", "820", and "826" (passed in the <ExtraService> request tag) are indicated, a content type (i.e., <ContentType>) of
       "DANGEROUSGOODS" will be required otherwise an error will return.
  - Estimated delivery information returned will reflect new HAZMAT service standards.
  - For HAZMAT, Web Tools will update the Shipping Services File Extra Service (ESC) fields
  - (SSFv2.0 D1, pos 44, 46) to include "857" (generic HAZMAT) and the new detailed HAZMAT extra services "813", "820", and "826" where supported reference above table in section 2.13.2

## 2.14.2 USPS HAZMAT Updates - Enforcement

- Summary: Web Tools will implement a phased approach for integrators to adopt the new HAZMAT extra service enumerations (passed in the <ExtraService> and <SpecialService> request tags) available Oct 27, 2022. Effective January 2023, Web Tools will require the additional HAZMAT extra service details to support increased Hazardous Materials (HAZMAT) visibility within the Postal network.
  - Integrators should specify the type of HAZMAT using the new HAZMAT extra services (passed in the <ExtraService> request tag) to enable new HAZMAT functionality.
    - <ContentType>="HAZMAT" will not be required.
    - Effective January 2023, if <ContentType>="HAZMAT" is included without additional HAZMAT extra service details provided in the request, Web Tools will return a new error requiring additional HAZMAT details.
